The Importance of Wills and Estate Planning

Estate planning is generally the use of Wills, Trusts, Durable Powers of Attorney and other documents to protect an individual's assets and financial decisions during their lifetime and beyond. Estate Planning can accomplish many important things for an individual. Among these are the following:

- Minimize state and inheritance taxes
- Provide for loved ones
- Preserve control over assets
- Clarify and protect wishes to avoid family disagreements
- Appoint a guardian to care for minor children
- Control age at which children receive inheritance
- Create flexibility as tax laws change
- Simplify administration of Estates
- Protect assets from creditors
- Select an individual to handle affairs in the event of incapacitation or death
- Avoid unnecessary legal expenses

In 2001 new tax laws were passed in the State of New Jersey which provide opportunities for individuals to preserve more of their estates for their heirs. The extent to which an individual's assets and wealth can be preserved varies depending on the year of death. With proper planning, an individual can create maximum flexibility in legal documents so that the estate will pay the minimum death taxes.

Every adult should have a Will regardless of the size of his or her estate. A Will is a legal document that provides for the distribution of an individual's assets after death and names a person to settle the estate. If you do not have a Will, then you surrender your right to define and direct how your want your estate settled and to whom you want your assets distributed. If you die without a Will (intestate) then your assets will be distributed in accordance with the Intestacy Statute of the State of New Jersey and an Administrator will have to be appointed through the Surrogate's Court for purposes of distributing the assets and administering the estate. In addition, the Surrogate will require a bond to be posted for the purpose of securing and protecting the assets of the estate. The bond is an expense that can be avoided, if you have a Will.

Please keep in mind that a Will is not a simple document and if it is not effectively drafted and properly executed it can create numerous problems. All individuals have different personal and financial backgrounds, needs and wishes and, therefore, specific attention must be paid to this information in order to effectively draft a Will for the purpose of carrying out an individual's wishes, as well as minimizing potential estate taxes.

Proper and adequate Estate Planning is extremely important to everyone. Whether you are young or old, have many valuable assets or only minimal assets, there are factors and issues which will impact on you and your family. Most of these issues can be addressed and handled appropriately through careful and proper planning techniques. Generally, once you have accomplished this, you should have your estate plan and related documents reviewed at least every five to six years with regard to future changes in both Federal and State inheritance and estate tax laws. Barring any unforeseen significant changes, this will be sufficient to adequately protect your interests.

Advantages Of Registering A Mark

A trademark is any word, name, symbol, or device, or any combination, used in commerce to identify and distinguish the goods of one manufacturer or seller from goods manufactured or sold by others, and to indicate the source of the goods. In short, a trademark is a brand name. Likewise, a service mark identifies and distinguishes the services of one provider from services provided by others, and to indicate the source of the services.

So what are the advantages to registering your mark? Registration of a mark provides notice nationwide of the trademark owner's claim and is evidence of ownership of the trademark. Registration of a mark can also be used as a basis for obtaining registration in foreign countries and may be filed with U.S. Customs Service to prevent importation of infringing foreign goods.

From a more practical standpoint, registering your mark allows the consumer to easily identify the source of the exact goods/services they wish to purchase. It also provides assurances to the consumer that they will receive the same quality and consistency each time they purchase and/or use your product and/or service. This is usually referred to as "goodwill." Over time, the goodwill associated with a mark can become a company's most valuable asset. While registration of a mark is not required to protect the mark, one of the biggest advantages in securing federal registration of a mark is that it allows the owner of the mark to bring actions in federal court for instances of trademark infringement. There are various remedies for trademark infringement, including: an injunction (an order preventing the defendant from further using the similar mark); monetary damages to compensate the plaintiff for any damages incurred (this includes actual damages to lost sales and injury to reputation and goodwill); and costs of the action including attorneys' fees and actual costs.

Trademarks are valid for ten years and may be renewed for additional ten-year periods as long as the mark continues to be in use in interstate commerce. Simply advertising in another state or offering your product or service on the Internet will satisfy the "interstate commerce" requirement.
